

# INMASS/MRP License Agreement

BEFORE YOU OPEN THE PACKAGE CONTAINING THE MEDIA, YOU SHOULD CAREFULLY READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT. BY OPENING THE PACKAGE, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS LICENSE AGREEMENT. IF YOU FIND ANY OF THE TERMS OF THIS LICENSE AGREEMENT OBJECTIONABLE, PLEASE CONTACT THE STRATFORD GROUP, INC. (INMASS/MRP) TO NEGOTIATE THEM PRIOR TO OPENING THE PACKAGE CONTAINING THE PROGRAMMING MEDIA. IF YOU AND INMASS/MRP ARE UNABLE TO NEGOTIATE A MUTUALLY SATISFACTORY RESOLUTION OF YOUR OBJECTIONS, YOUR PLACE OF PURCHASE WILL REFUND YOUR LICENSE PRICE IF YOU RETURN THE UNOPENED PACKAGE CONTAINING THE MEDIA, WITH THE SEALS UNBROKEN, AS WELL AS YOUR SALES RECEIPT AND THE END USER DOCUMENTATION WITHIN TEN (10) DAYS OF PURCHASE.

## LICENSE AGREEMENT

Subject to the provisions contained herein, The Stratford Group, Inc., ("INMASS/MRP") hereby grants to you a non-exclusive license to use its proprietary computer software product INMASS/MRP ("Software") contained in the package.

**SOFTWARE AND DOCUMENTATION.** INMASS/MRP shall furnish the Software to you on media in machine-readable object code form and may also provide INMASS/MRP's standard documentation ("Documentation") containing instructions for operation and use of the Software.

This is a legal agreement between you, the end user, and The Stratford Group, Inc. ("INMASS/MRP"). The enclosed INMASS/MRP software program (the "SOFTWARE") is licensed by The Stratford Group, Inc. to the original purchaser of this License and any subsequent owner of the product for use only on the terms set forth herein. Please read this license agreement. Opening the accompanying package of software program materials indicates that you accept these terms. If you do not agree to these terms, return this product, with the package unopened, to your dealer within ten (10) days.

**GRANT OF LICENSE.** The Stratford Group, Inc. (INMASS/MRP) grants to you the right to use one copy of the enclosed INMASS/MRP SOFTWARE on a single terminal connected to a single computer (i.e. with a single CPU) or to a network server. If you install the SOFTWARE on more than one network in more than one location, you must purchase a separate copy of the SOFTWARE for each network on which the SOFTWARE will be operated.

**GRANT OF NETWORK LICENSE.** If you are acquiring a version of INMASS/MRP specifically configured for network use, The Stratford Group, Inc. grants to you the right to use the SOFTWARE on a LICENSED COMPUTER NETWORK as provided below. A computer network is any combination of two or more terminals that are electronically linked and capable of sharing the use of a single software program. A LICENSED COMPUTER NETWORK is a computer network for which you have acquired and dedicated at least one (1) INMASS/MRP standard version of the INMASS/MRP SOFTWARE.

**LICENSE TERM.** The term of this license commences upon delivery of the Software to you and your acceptance of the terms of this agreement. Opening the package containing the software demonstrates acceptance of the provisions of this license agreement. The term of the license is perpetual unless earlier terminated upon default by one of the parties or as otherwise set forth herein. The Stratford Group, Inc. (INMASS/MRP) may, at its discretion, modify fees or charges for the support and/or maintenance of the software, change the prices of existing services or product elements, and/or change the names and payment requirements of fees or charges. Failure of the user to meet any requirements for payment of any charges billed by Stratford for more than ninety (90) days will place the user in default of this License Agreement and subject to the immediate removal, repossession, and/or deactivation of the INMASS/MRP software by Stratford or its representatives or agents and/or a renegotiation of this license by the parties prior to any continued use of the software. If the License Holder is in default under this provision, use of INMASS/MRP software must be terminated immediately by the user until the default is remedied.

**TRADEMARK AND COPYRIGHT.** INMASS, INMASS II, and INMASS/MRP are registered trademarks of The Stratford Group, Inc. The SOFTWARE is protected by United States copyright laws and international treaty provisions, and, therefore, you must treat the SOFTWARE like any other copyrighted material (e.g., a book or musical recording) **except** that you either may (a) make one copy of the SOFTWARE solely for backup or archival purposes providing that you reproduce all copyright and other proprietary notices that are on the original copy of the SOFTWARE provided to you and affix such notices to each copy or (b) transfer the SOFTWARE to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the documentation accompanying the SOFTWARE.

**TITLE.** Title, and ownership right, and intellectual property rights in and to the Software and Documentation shall remain in The Stratford Group, Inc.. The Software is provided for your own internal use under this license. This license does not include the right to sublicense and is personal to you and/or your company and therefore may not be assigned (by operation of law or otherwise) or transferred without the prior written consent of The Stratford Group, Inc. You acknowledge that the Software in source code form remains a confidential trade secret of The Stratford Group, Inc. and therefore you are not to attempt to decipher or decompile the Software or develop source code for the Software or knowingly allow others to do so. You also agree not to develop registration numbers, to alter the existing Number(s), or to determine how INMASS/MRP (INMASS II) develops such registration numbers or password(s) or to knowingly allow others to do so.

**UPDATES.** This license does not grant you any right, license, or interest in or to any improvements, modifications, enhancements, or updates to the Software and documentation. Updates, if available, may be obtained by you at INMASS/MRP's then current standard pricing, terms, and conditions. If the media inside the package is an update, then the Documentation provided may be limited in scope and a new password(s) or registration number(s) may or may not be required or supplied by INMASS/MRP.

**OTHER RESTRICTIONS.** You may not rent or lease the INMASS/MRP SOFTWARE in your possession to a third party, but you may transfer the SOFTWARE and accompanying written materials on a permanent basis provided you retain no copies and the recipient agrees to the terms of this Agreement and registers the acquired SOFTWARE with the Stratford Group, Inc.. You may not decompile, disassemble, reverse engineer, or create derivative works from the SOFTWARE.

**DUAL MEDIA SOFTWARE.** If the SOFTWARE package contains both 3½" and CD disks, then you may use only the disks appropriate for your single-user computer or LICENSED COMPUTER NETWORK. You may not use the other disks on another computer or computer network or loan, rent, lease, or transfer them to another user.

**GOVERNMENT LICENSEE.** If you are acquiring the SOFTWARE on behalf of any unit or agency of the United States Government, the following provisions apply:

The Government acknowledges The Stratford Group, Inc.'s representation that the INMASS II, INMASS/MRP SOFTWARE and its documentation were developed at private expense and no part of them is in the public domain.

The Government acknowledges The Stratford Group, Inc.'s representation that the SOFTWARE is "Restricted Computer Software" as that term is defined in Clause 52.227-19 of the Federal Acquisition Regulations (FAR) and is "Commercial Computer Software" as that term is defined in Subpart 227.401 of the Department of Defense Federal Acquisition Regulation Supplement (DFARS).

The Government agrees that:

(i) if the SOFTWARE is supplied to the Department of Defense (DoD), the SOFTWARE is classified as "Commercial Computer SOFTWARE" and the Government is acquiring only "restricted rights" in the SOFTWARE and its documentation as that term is defined in Clause 52.227-7013 (c) (1) of the DFARS, and

(ii) if the SOFTWARE is supplied to any unit or agency of the United States Government other than DoD, the Government's rights in the SOFTWARE and its documentation will be as defined in Clause 52.227-19 (c) (2) of the FAR.

**RESTRICTED RIGHTS LEGEND.** Use, duplication, or disclosure by the Government is subject to restrictions as set forth in subparagraph (c) (1) (ii) of the Rights in Technical Data and Computer Software clause at DFARS 52.227-7013. The Stratford Group, Inc., Postal Drawer 41000, Tucson, AZ 85717.

**EXPORT LAW ASSURANCES.** You acknowledge and agree that the SOFTWARE is subject to restrictions and controls imposed by the United States Export Administration Act (the "Act") and the regulations thereunder. You agree and certify that neither the SOFTWARE nor any direct product thereof is being or will be acquired, shipped, transferred or re-exported, directly or indirectly, into any country prohibited by the Act and the regulations thereunder or will be used for any purpose prohibited by the same.

**LIMITED WARRANTY.** INMASS/MRP warrants that for a period of thirty (30) days from the date you, the original purchaser, purchased a license to it, the SOFTWARE, if operated as directed, will substantially achieve the functionality described in the Documentation. INMASS/MRP does not warrant, however, that your use of the Software will be uninterrupted or that the operation of the Software will be error-free or that all software errors will be corrected. The Stratford Group, Inc. is not responsible for problems caused by changes in the operating characteristics of computer hardware or computer operating systems nor for problems in the interaction of the SOFTWARE with non-INMASS/MRP software. The Stratford Group, Inc. will have no responsibility to replace or refund the purchase price of media damaged by accident, abuse, or misapplication. INMASS/MRP also warrants that the media containing the Software, if provided by INMASS/MRP, is free from defects in material and workmanship and will so remain for ninety (90) days from the date you, the original purchaser, purchased a license to it. INMASS/MRP's sole and exclusive obligation and liability for any breach of this warranty, and your sole remedy under this warranty, shall be, in INMASS/MRP's sole discretion: (1) to replace your defective media; or (2) to repair or correct your defective media so that it will conform to the above warranty; (3) to advise you how to achieve substantially the same functionality with the Software as described in the Documentation through a procedure different from that set forth in the Documentation; or (4) to refund the purchase price paid by you for the license to the defective Software. Repaired, corrected, or replaced Software and Documentation shall be covered by this limited warranty for the period remaining under the warranty that covered the original Software, or if longer, for thirty (30) days after the date (a) of shipment to you of the repaired or replaced Software, or (b) the first date on which INMASS/MRP technical support staff advised you how to operate the Software so as to avoid the difficulty that you were having in achieving functionality. Only if you inform INMASS/MRP of your problem with the Software during the applicable warranty period will INMASS/MRP be obligated to honor this warranty. You must contact INMASS/MRP by telephone, facsimile, or by letter to inform INMASS/MRP of the problem.

If any modifications are made to the Software by you, or by someone on your behalf, during the warranty period, if the media is subjected to accident, abuse, or improper use, or if you violate the terms of this Agreement, then this warranty shall immediately be terminated. This warranty shall not apply if the SOFTWARE is used on or in conjunction with hardware or programs other than the unmodified version of hardware and programs with which the Software was designated to be used as described in the Documentation.

In order to make a claim under this warranty you must return the defective item with your receipt to your authorized dealer, postage prepaid, within the warranty period.

THE ABOVE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY THE STRATFORD GROUP, INC., INMASS/MRP, ITS EMPLOYEES, DISTRIBUTORS, DEALERS OR AGENTS SHALL INCREASE THE SCOPE OF THE ABOVE WARRANTIES OR CREATE ANY NEW WARRANTIES.

SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, ANY IMPLIED WARRANTIES ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE DATE OF DELIVERY OF THE SOFTWARE. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

**LIMITATIONS OF REMEDIES.** REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL INMASS/MRP BE LIABLE TO YOU FOR ANY SPECIAL, CONSEQUENTIAL, INDIRECT OR SIMILAR DAMAGES, INCLUDING ANY LOST PROFITS OR LOST DATA ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE OR ANY DATA SUPPLIED THEREWITH EVEN IF INMASS/MRP OR AN AUTHORIZED INMASS/MRP DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY. SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. IN NO CASE SHALL INMASS/MRP LIABILITY EXCEED THE PURCHASE PRICE FOR THE SOFTWARE.

**TERMINATION.** Either party may terminate this Agreement immediately in the event of default by the other party. No cancellation by buyer for default shall be effective unless The Stratford Group, Inc. shall have failed to correct such alleged default within thirty (30) days after receipt by The Stratford Group, Inc. of a written notice of default. The Stratford Group, Inc. shall not be liable for any delay or failure to perform due to any cause beyond its control. Causes include, but are not limited to, strike, acts of God, acts of the Buyer, interruptions of transportation or inability to obtain necessary labor, materials or facilities. The delivery schedule shall be considered extended by a period of time equal to the time lost because of any excusable delay. In the event The Stratford Group, Inc. is unable to wholly or partially perform because of any cause beyond its control, The Stratford Group, Inc. may terminate this order without any liability to Buyer. Buyer may terminate this order, other than for default, only upon payment of The Stratford's Group, Inc. costs reasonably allocated to the terminated portion of the work in accord with generally accepted accounting principles and practices, plus a reasonable profit on such costs. If the termination includes custom product, cancellation charges for such product shall equal the order price for the total work-in-progress. Unless otherwise agreed and confirmed in writing, custom items scheduled for shipment are not subject to revision, reschedule or termination within thirty (30) days prior to shipment. Upon any termination of this Agreement, you shall immediately discontinue the use of the Software and shall within ten (10) days return to The Stratford Group, Inc. (INMASS/MRP), all copies of the Software and Documentation with an independently signed affidavit attesting to the fact that the software in its entirety has been removed from any and all computers the user may have or to which he may have access. You also may terminate this Agreement at any time by destroying the Software and Documentation and all copies thereof & notify The Stratford Group, Inc., in writing, of the completion of such action. Your obligations to pay accrued charges and fees shall survive any termination of this Agreement.

**MISCELLANEOUS.** This agreement represents the complete and exclusive statement of the agreements concerning this license between the parties and supersedes all prior agreements and representations between them. It may be amended only by a writing executed by both parties. THE ACCEPTANCE OF ANY PURCHASE ORDER PLACED BY YOU FOR THE SOFTWARE AND/OR DOCUMENTATION IS EXPRESSLY MADE CONDITIONAL ON YOUR ASSENT TO THE TERMS AND CONDITIONS SET FORTH HEREIN, AND INMASS/MRP AGREES TO FURNISH THE SOFTWARE AND DOCUMENTATION ONLY UPON THESE TERMS AND CONDITIONS AND NOT THOSE CONTAINED IN YOUR PURCHASE ORDER. If any provision of this Agreement is held to be ineffective, unenforceable, or illegal under certain circumstances for any reason, such decision shall not affect the validity or enforceability (1) of such provision under other circumstances or (2) of the remaining provisions hereof under all circumstances and such provision shall be reformed to and only to the extent necessary to make it effective, enforceable, and legal under such circumstances. All headings are solely for convenience and shall not be considered in interpreting this Agreement. This Agreement shall be governed by and construed under Arizona law as such law applies to agreements between Arizona residents entered into and to be performed entirely within Arizona, except as required by U.S. Government rules and regulations to be governed by Federal law. If any provision of this agreement is held invalid, the remainder of the agreement shall continue in full force and effect. Other than employees of The Stratford Group, Inc., your supplier/dealer of INMASS II (INMASS/MRP) Software is not an agent of The Stratford Group, Inc., but an independent contractor.
